Qualifications required for membership

1. The applicant should have received his/her professional education and training from educational institutions that are accredited by the Councils on Chiropractic Education International (CCEI) of the USA, Canada, Australasia and Europe.
2. The applicant must be licensed to practice Chiropractic:
 - If the applicant is practicing in Hong Kong, he/she must be registered with the Chiropractors Council of Hong Kong.
 - If the applicant is practicing elsewhere, he/she must be registered with the statutory professional regulatory body of that country.
 - If the applicant is practicing in a country where there is no professional regulation, he/she must be a member of the local chiropractic association that is recognized by the World Federation of Chiropractic.
 - At the discretion of the HKCA Council.

Application Process and Fees

1. Application forms may be obtained by request from The Hon Secretary, Hong Kong Chiropractors Association Limited, Unit 2, 13th Floor, Kin Tak Fung Commercial Building, 467- 473 Hennessy Road, Hong Kong, China or may be downloaded from our website www.hkca.org.
2. All sections of the application form including the declaration must be completed. Please use black ink and write in block letters or type.
3. Supporting documents to be submitted with completed application form include:
 - Photocopy of the diploma from your chiropractic college/university
 - Photocopy of the appropriate certificate of registration
4. Payment for the Annual Membership Fee of **HK\$4,000** must be made at the time of lodging an application.

If you are practicing for the first time in Hong Kong and coming from overseas, you are entitled to a discounted Annual Membership Fee of **HK\$3,500.
